

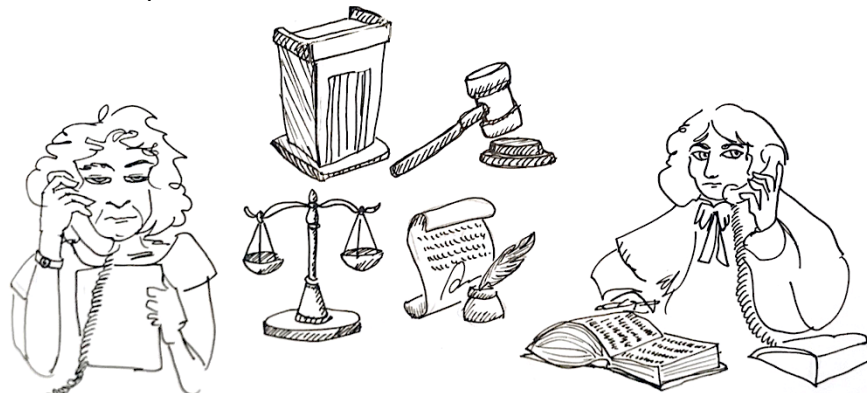

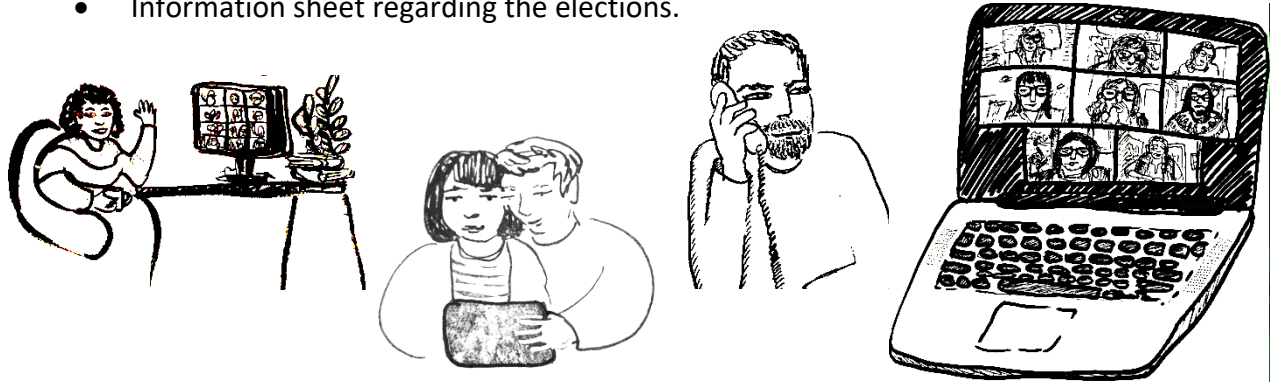

The meeting will be in French, simultaneous translation in English will be provided.
